The surcharge is the amount resulting from dividing the total program costs by the number of gallons sold to non-participating water division customers in the past 12-month tracking period.

#### Wastewater Division

A surcharge of \$0.03 will be applied each month to the bills of non-participating wastewater division customers for recovery of the costs (discounts, direct costs, and carrying charges) associated with the ARWW program. The surcharge is the amount resulting from dividing the total program costs by the number of bills issued to non-participating wastewater division customers in the past 12-month tracking period.
