

**REVISED PUBLIC NOTICE OF HEARING AND PUBLIC COMMENT MEETING  
ON THE APPLICATION OF LIBERTY UTILITIES (BEARDSLEY WATER) CORP.  
FOR THE SETTING OF RATES AND CHARGES FOR  
WATER UTILITY SERVICE AND FINANCING APPROVAL  
(DOCKET NOS. W-02074A-23-0337, AND W-02074A-24-0030)**

**Summary**

On December 28, 2023, Liberty Utilities (Beardsley Water) Corp. (“Liberty Beardsley”) filed an application with the Arizona Corporation Commission (“Commission”), in Docket No. W-02074A-23-0337 requesting adjustments to its rates and charges for water utility service. On January 30, 2024, Liberty Beardsley filed an application with the Commission in Docket No. W-02074A-24-0030 requesting authority to issue evidence of indebtedness in connection with the purchase of equity.

**The hearing in this matter, which was scheduled to commence on October 28, 2024, and continue through November 1, 2024, is vacated. The hearing has been rescheduled to commence on Monday, March 24, 2025, at 10:00 a.m. at the Commission’s offices at 400 West Congress, Room 222, Tucson, Arizona 85701, and shall continue as necessary at 9:00 a.m. on Tuesday, March 25 through March 28, 2025, at the Commission’s offices at 1200 West Washington Street, Phoenix, Arizona 85007.**

**Public comment meetings scheduled for October 8, 24, 28, and 29, 2024, shall be held as scheduled. Two additional meetings for public comment will be held on March 24 and 25, 2025.**

**The revised hearing dates and public meeting dates, times and locations are listed below for your reference.**

As part of this rate case, Liberty Beardsley is also requesting consideration of consolidation with Liberty Utilities (Bella Vista Water) Corp. (“Liberty Bella Vista”), Liberty Utilities (Cordes Lakes Water) Corp. (“Liberty Cordes Lakes”) and Liberty Utilities (Rio Rico Water & Sewer) Corp. (“Liberty Rio Rico”). Liberty Bella Vista, Liberty Cordes Lakes and Liberty Rio Rico have concurrently filed applications requesting (1) adjustments to their rates and charges for water and wastewater utility service, and (2) evidence of indebtedness in connection with the purchase of equity.

The eight dockets related to adjustments to rates and charges for water and wastewater service and issuing evidence of indebtedness in connection with the purchase of equity were consolidated for hearing purposes.

**Liberty Beardsley Rate Request (Docket No. W-02074A-23-0337)**

In its rate application, Liberty Beardsley proposes rates both on a stand-alone basis and on a consolidated basis with Liberty Cordes Lakes, Liberty Bella Vista, and Liberty Rio Rico.

**Stand-Alone Basis**

On a stand-alone basis, Liberty Beardsley requests authorization to increase its water rates to generate total revenues of \$2,679,766. This would constitute an increase in revenues of \$692,843 or 34.87 percent, over adjusted test year revenues of \$1,986,923, resulting in an 8.95 percent rate of return on Liberty Beardsley’s

proposed fair value rate base of \$6,543,862. If Liberty Beardsley's request is granted as proposed, on a stand-alone basis, the average monthly bill for a residential customer would be \$69.18, a \$17.08 or 32.77 percent increase to the present average monthly residential bill of \$52.10.

In addition, Liberty Beardsley requests approval of a rate case expense surcharge and has calculated the proposed surcharge to be \$0.92 per customer per month for three years on a stand-alone basis. With the rate case expense surcharge, on average, a residential customer would pay \$70.10, a \$18.00 or 34.55 percent increase to their current monthly bill.

### **Consolidated Rates**

If Liberty Beardsley's rates are consolidated with those of Liberty Bella Vista, Liberty Cordes Lakes, and Liberty Rio Rico, Liberty Beardsley residential customers, on average, would see a monthly increase of \$3.38, or 6.50 percent, from \$52.10 to \$55.48. With a proposed rate case expense surcharge of \$0.86 per customer per month, residential customers, on average, would pay \$56.34, a \$4.24 or 8.14 percent increase.

Liberty Beardsley also proposes adoption of a Customer Assistance Tariff, the cost for which would be assessed against all non-participating customers, to be recalculated annually.

### **Liberty Beardsley Request for Financing (Docket No. W-02074A-24-0030)**

Liberty Beardsley seeks Commission approval of long-term debt financing for the purpose of rebalancing Liberty Beardsley's capital structure of 100 percent equity and 0 percent debt to a capital structure of 54 percent equity and 46 percent debt (Docket No. W-02074A-24-0030). If Liberty Beardsley's application is granted, Liberty Beardsley will borrow the amount necessary to achieve a capital structure consisting of 54 percent equity and 46 percent debt. This amount is currently estimated to be \$4,500,000.

In the event of the consolidation of Liberty Beardsley, Liberty Bella Vista, Liberty Cordes Lakes, and Liberty Rio Rico, as requested for consideration, Liberty Rio Rico (Consolidated) seeks Commission approval of long-term debt financing for the purpose of rebalancing capital structure of 100 percent equity and 0 percent debt to a capital structure of 54 percent equity and 46 percent debt. This amount is currently estimated to be \$33,000,000.

**THE COMMISSION IS NOT BOUND BY THE PROPOSALS OF LIBERTY BEARDSLEY, STAFF, OR ANY INTERVENORS. THE COMMISSION WILL DETERMINE THE APPROPRIATE RELIEF TO BE GRANTED IN RESPONSE TO THE APPLICATION OF LIBERTY BEARDSLEY BASED ON THE EVIDENCE PRESENTED IN THIS MATTER. THE FINAL RATES APPROVED BY THE COMMISSION MAY BE HIGHER, LOWER, OR DIFFERENT THAN THE RATES PROPOSED BY LIBERTY BEARDSLEY OR BY OTHER PARTIES.**
