On June 22, 2015, Liberty Utilities (Black Mountain Sewer) Corp. (the "Company") filed a rate application with the Arizona Corporation Commission ("Commission"). The Company requested a rate increase that would produce a just and reasonable rate of return. At the conclusion of this rate proceeding, the Commission issued Decision No. 75510, authorizing increases for the Company. The rates approved will result in an **increase** for the typical residential customer of \$14.26, from \$65.24 per month to \$79.50 per month, or 21.86 percent.
