NEW RATES

Effective April 1, 2017

On March 3, 2016, Liberty Utilities (Entrada Del Oro Sewer) Corp. ("Company") filed a rate application with the Arizona Corporation Commission ("Commission"). The Company requested a rate increase that would produce a just and reasonable rate of return. The Company also filed a financing application, on March 7, 2016, in which it requested authority from the Commission to incur long term debt in an amount not to exceed \$1,750,000. The rate and financing proceedings were consolidated. At the conclusion, the Commission issued Decision No. 76019 (March 22, 2017) authorizing rate increases for the Company as set forth herein and granting the Company's financing request.

The decision includes a phase-in of rates for residential customers over five years as follows:

The year 1 rate is \$86 per month, an increase of \$16 or 22.9 percent over present rates.

The year 2 rate will be \$93 per month, an increase of \$23 or 32.9 percent over present rates. This represents an incremental increase of \$7 or 8.1 percent over year l rate of \$86.

The year 3 rate will be \$99 per month, an increase of \$29 or 41.4 percent over present rates. This represents an incremental increase of \$6 or 6.5 percent over year 2 rate of \$93.

The year 4 rate will be \$104 per month, an increase of \$34 or 48.6 percent over present rates. This represents an incremental increase of \$5 or 5.1 percent over year 3 rate of \$99.

The year 5 and final rate will be \$108 per month, an increase of \$38 or 54.3 percent over present rates. This represents an incremental increase of \$4 or 3.8 percent over year 4 rate of \$104.
